# **Report 2013**

### **Executive summary**

Four meetings, new Model Code, evaluations of five codes, preparation Stockholm, work on new guidelines

#### Introduction

Board of Ethics is composed of 22 members (4 corresponding); 15 really active members. We have done our usual activities: evaluation of the consistency with the Meta Code of the Codes of Member associations (The Netherlands, France, Switzerland, Russia) and candidate association (Romania). We also had an hard work on the redaction of a Model Code as requested by EC. Finally to be mentioned: the preparation of guidelines on teaching ethics, ethics in supervision and advertising.

- 2. Accept the codes of following countries as consistent with the Meta Code (with eventually remarks from the Board of Ethics): The Netherlands, Russia, France, Switzerland, Romania
- 3. Give mission to the Board of Ethics to:

Prepare guidelines on teaching ethics in psychology

Prepare guidelines on ethics in supervision

Continue to develop the website on ethics

Continue the evaluation of the consistency of new codes (or new versions of codes) of Efpa members associations

Prepare Ethics Track for the ECP 2015 Milano
